Labs have become significantly more expensive for many patients to obtain. If they are drawn in the office and sent off to a national or locally independent lab, they are subjected to whatever charge and expense the lab passes on to them. Most commonly patients have no way to know ahead of time what that expense will be. Neither do their healthcare providers. These labs are necessary, but almost always overpriced.

If a patient goes to a hospital lab, those typical lab charges are an even higher expense to the patient. In the past, people with 'good health insurance' had excellent coverage for lab work. These days, business employees and individual patients frequently have plans that require meeting a significant deductible before the plan will pay for laboratory services, or insurance only pays for certain services and not others. Self-pay patients are simply at the mercy of the labs' business practices. Patients often don't know they have choices.

This is what they typically receive some time after the lab services have been drawn and performed:

"After your claim is processed, you'll receive an Explanation of Benefits (EOB) from your insurance company. The EOB will tell you how much your insurance will pay for your lab services. You will be responsible for the balance." *Vague at best.*
