HDHP (High Deductible Health Plans)

Preventive lab tests: HDHPs are required to cover some preventive services, including some lab tests, at no cost to you. You don't pay a deductible or copay for these tests. Examples include blood pressure, cholesterol, and diabetes screenings.

Diagnostic Lab Tests: If you need lab work for diagnostic purposes (trying to figure out what's wrong) these labs will likely be subject to your deductible (not paid for). Once you have paid the out-of-pocket amount required by your plan, your insurance will then start covering some percentage of the expense.

High Deductible, High Cost: Because HDHPs have a higher deductible than traditional plans, you will likely have to pay more out-of-pocket for labs before your insurance starts covering their share.

Cost-sharing: Even after you meet your deductible, you will still be responsible for some percentage of the cost. You will continue to pay coinsurance until you reach your out-of-pocket maximum for that year.

One-time use: Affirm virtual cards are typically designed for a single use.

Expiration: The virtual card expires within 24 hours of issuance.

PayPal

simply pick the PayPal option from MESH Invoicing

if you already have a PayPal account (recommended) just use it now

if you choose payPal for checkout and don't have an existing account, they process new accounts immediately and the credit check is a 'soft pull' only, which does not affect your credit

With PayPal you can pay in full, 'PayIn4' (pay every 2 weeks x 4 payments, interest free), or arrange monthly Terms are per PayPal, not MESH

<u>Klarna</u> offers a virtual card, called the Klarna Card, which can be used for online purchases where Visa is accepted. Once approved, the virtual card is available in the Klarna app and can be added to digital wallets like Apple Pay or Google Pay.

Here's how it works:

Apply and get approved: You can apply for the Klarna Card through the Klarna app or website.
